This is a summary of the annual report for the Council of Independent Colleges in Virginia Benefits Consortium, Inc. Health Plan, (Employer Identification No. 27-1367957, Plan No. 501) for the period January 1, 2010 to December 31, 2010. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Council of Independent Colleges in Virginia Benefits Consortium, Inc. has committed itself to pay all health claims incurred under the terms of the plan.

The Plan has contracts with Anthem Health Plans of Virginia and HealthKeepers, Inc. to pay all vision claims incurred under the terms of the plan. The total premiums paid for the year beginning January 1, 2010 and ending December 31, 2010 were \$34,153.

BASIC FINANCIAL STATEMENT

The value of plan assets, after subtracting liabilities of the plan, was \$1,232,403 as of December 31, 2010 compared to \$0 as of January 1, 2010. During the plan year the plan experienced an increase in its net assets of \$1,232,403. During the plan year, the plan had total income of \$22,308,984. This income included employer contributions of \$14,542,285, employee contributions of \$7,764,798 and earnings from investments of \$1,901. Plan expenses were \$21,076,581. These expenses included \$2,086,679 in administrative expenses and \$18,989,902 in benefits paid to participants and beneficiaries.
