

## Summary Annual Report

### MARY BALDWIN COLLEGE DEFINED CONTRIBUTION PLAN

This is a summary of the annual report for the MARY BALDWIN COLLEGE DEFINED CONTRIBUTION PLAN, (Employer Identification No. 54-0506319, Plan No. 001) for the period July 1, 2009 to June 30, 2010. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

#### BASIC FINANCIAL STATEMENT

Benefits under the plan are provided by a trust (benefits are provided in whole from trust funds). Plan expenses were \$1,288,633. These expenses included \$1,288,633 in benefits paid to participants and beneficiaries. A total of 695 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$23,384,487 as of June 30, 2010 compared to \$22,159,901 as of July 1, 2009. During the plan year the plan experienced an increase in its net assets of \$1,224,586. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. The plan had total income of \$2,513,989, including employer contributions of \$879,790 and earnings from investments of \$1,634,041.

5. Information regarding any common or collective trust, pooled separate accounts, master trusts or 103-12 investment entities in which the plan participates.
